**Erasmus+ International Credit Mobility Program Call for the allocation of 8 scholarships for mobility for study or traineeship reserved to students enrolled to Universidad del Pacifico, Lima, Peru. Minutes of the Selection Committee Meeting, concerning the applications received by August 2nd, 2025 for traineeship mobilities starting after April 1st 2025**

On October 3rd, 2025, at 5:00 PM Italian time, the selection committee met online to carry out the selection procedure for the allocation of the Erasmus+ scholarships for International Credit Mobility for students enrolled at Universidad del Pacifico, Lima (Peru), who applied for an internship position at FAO, as envisaged by art. 7 of the Call for applications issued with D.R. no. 687 of 23.07.2024.

**Available Positions:**

The committee, after careful examination of the notice of the selection procedure, and taking into account that four positions have already been awarded, verifies that the positions available for mobility as per art. 2 of the call for applications:

Professor Maximo Torero recalls however, that, for this second selection, only one traineeship position is available at FAO, further positions being available for the third call in early 2026.

The committee establishes that for candidates applying for traineeship positions at FAO, the score related to the Learning Agreement should be assigned by evaluating the required skills, as indicated in art. 8 of the call for applications.

The Committee proceeds to assign the following scores to the candidates for the quality of the Motivation Letter, language skills, and learning agreement:
