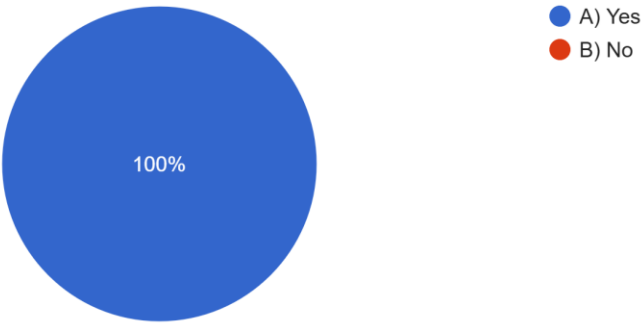

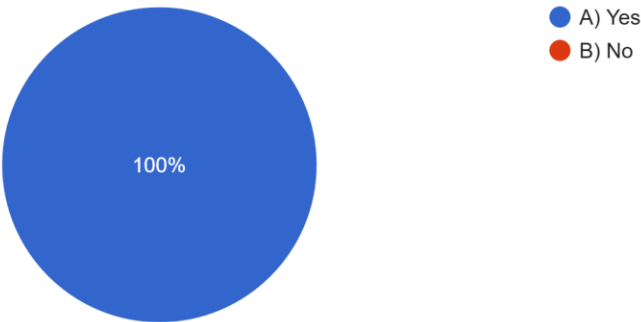
Sez. A - 1) Does the PhD Program include structured training activities (courses, seminars, workshops)?

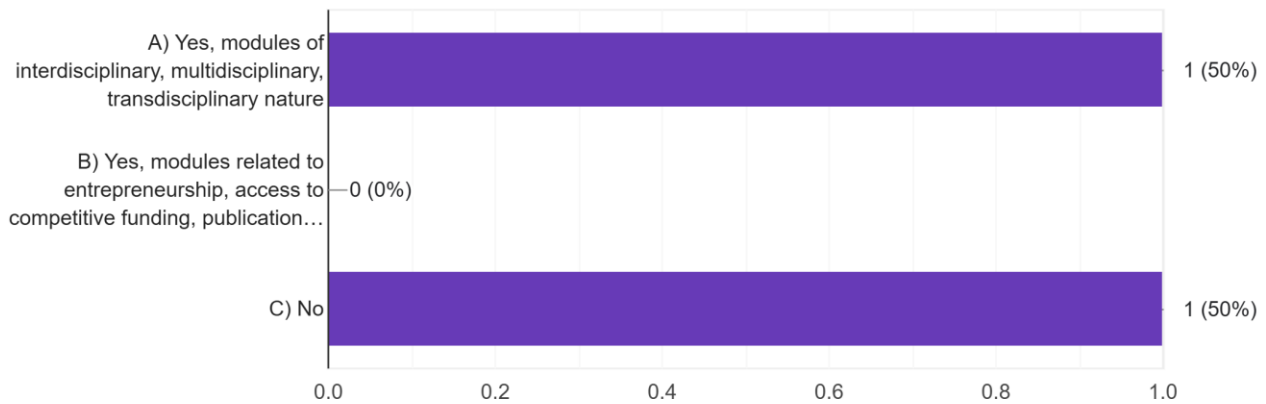
Sez. A - 2) Is the training activity distinct from that provided in courses for master's degrees?

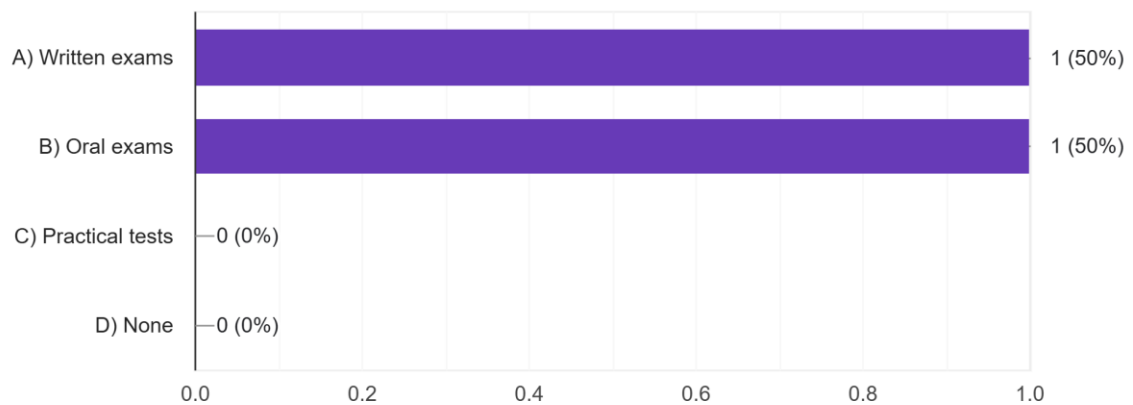
Sez. A - 3) Did the training activity also include additional modules? (possible more than one answer)

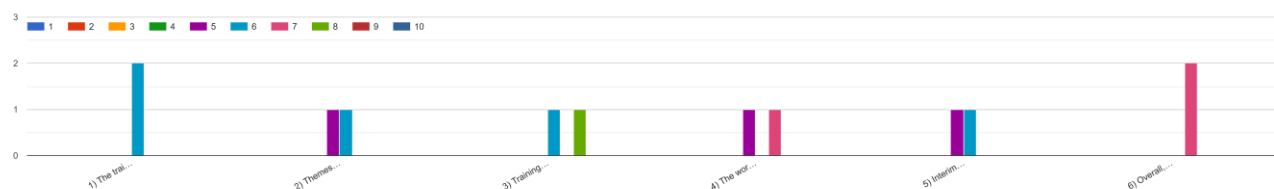


Sez. A - 4) What are the planned methods for interim assessments of training activities during the PhD Program? (possible more than one answer)

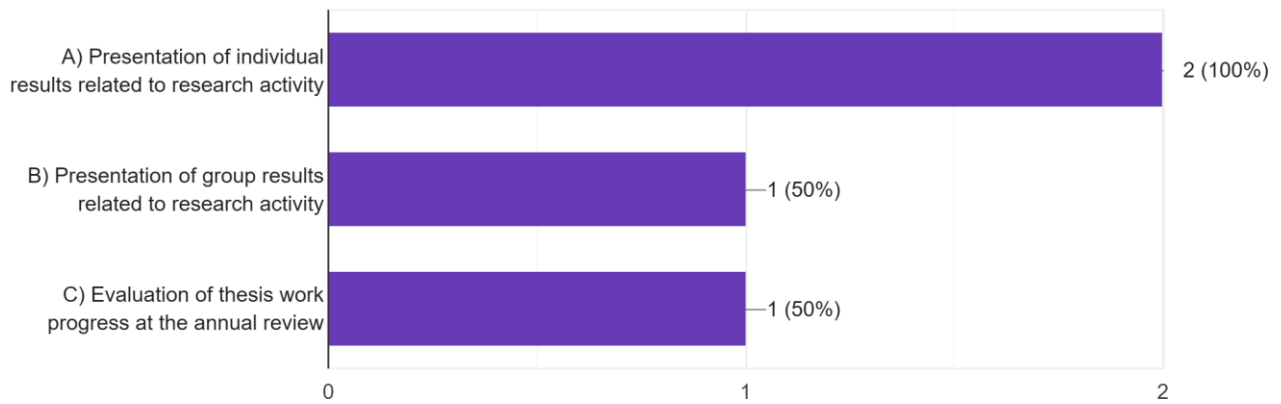

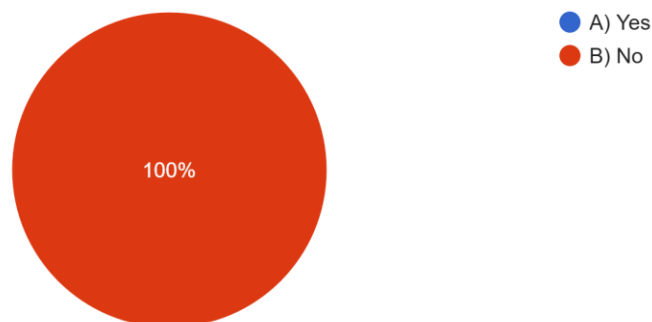
Sez. A - 5) What are the planned methods for monitoring research activities during the PhD Program? (Possible more than one answer)

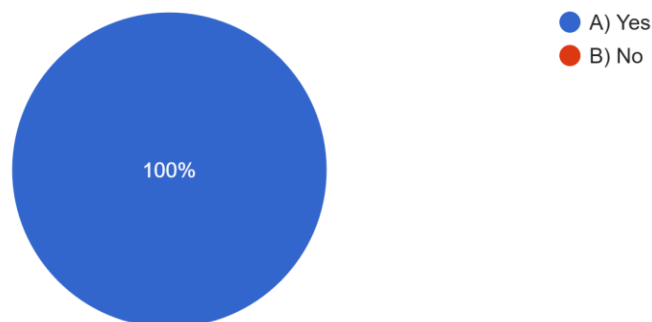
Sez. A - 6) Have you used or are you currently using the additional budget provided by DM 226/2021 for at least 10% of research activities?

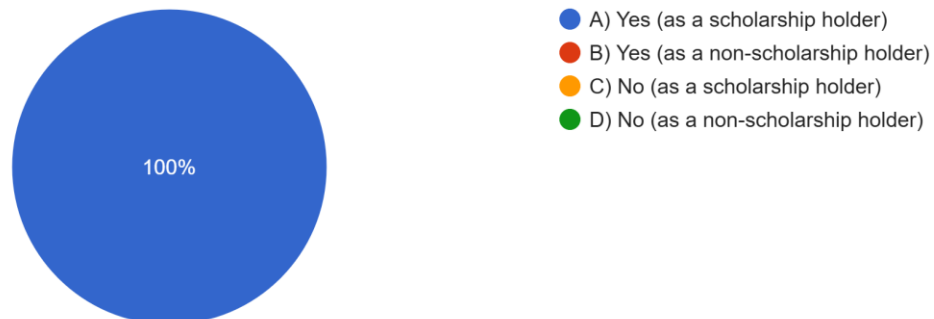
Sez. A - 7) Have you spent, are you currently spending, or do you plan to spend periods of study or research abroad consistent with the educational project?

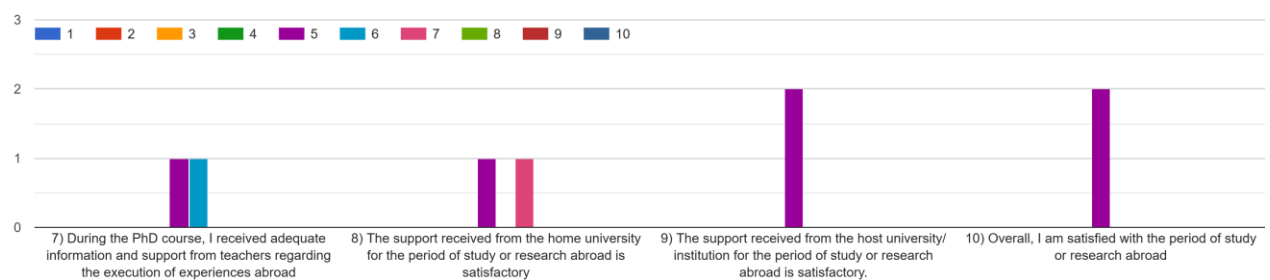


Sez. A - 8) Have you used, are you currently using, or do you plan to use the increase in the scholarship by up to 50% for periods of mobility abroad?

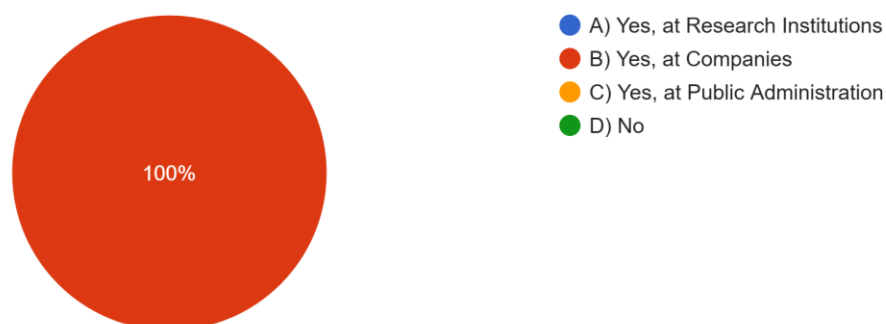

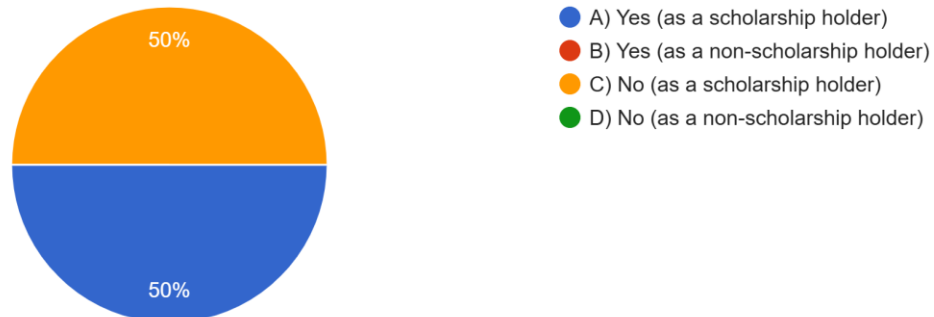

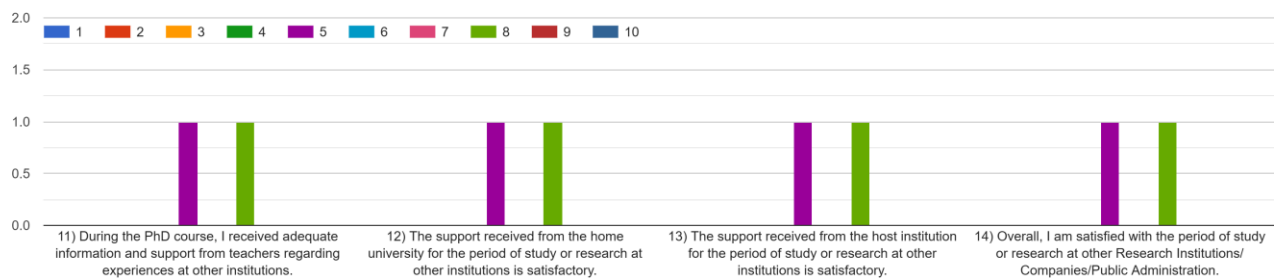


Sez. A - 11) Have you received or are you receiving financial support for periods at Research Institutions, Companies, Public Administration?

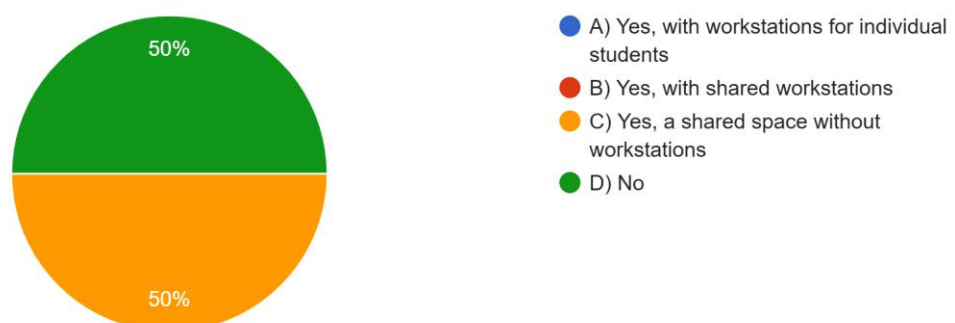

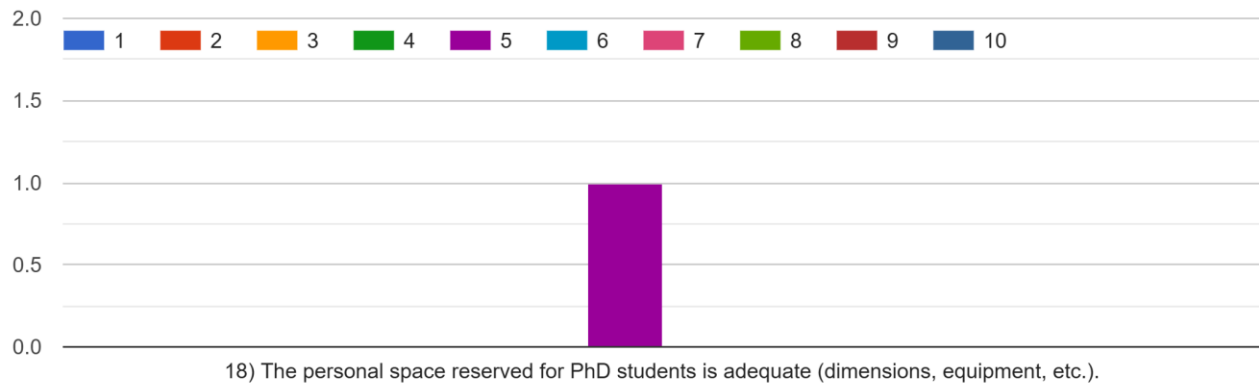


Sez. A - 13) Is there a workspace provided for PhD students at your PhD Program location?

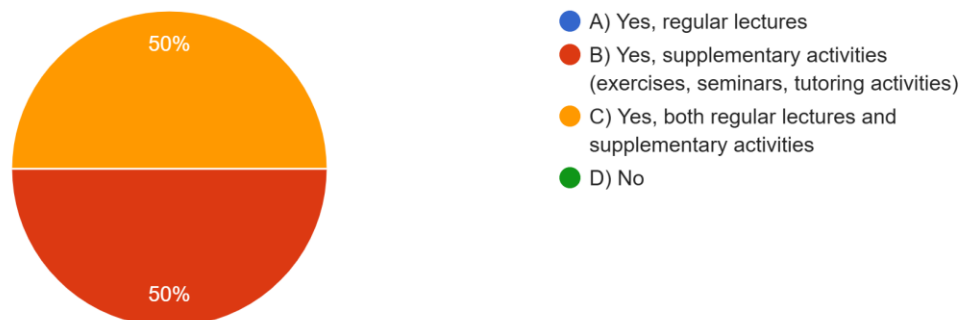

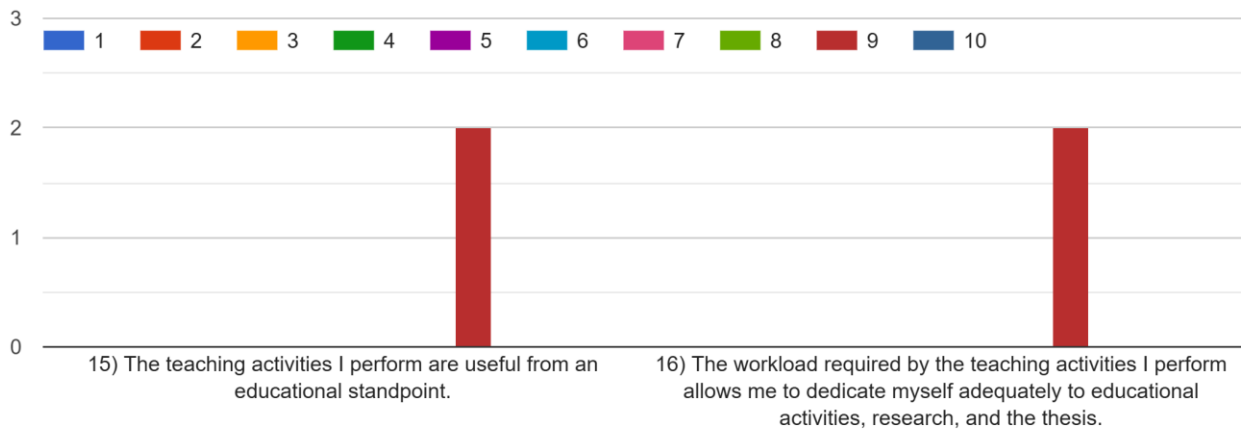


Sez. A - 14) Have you personally conducted or are you currently conducting teaching or teaching support activities during your PhD Program?

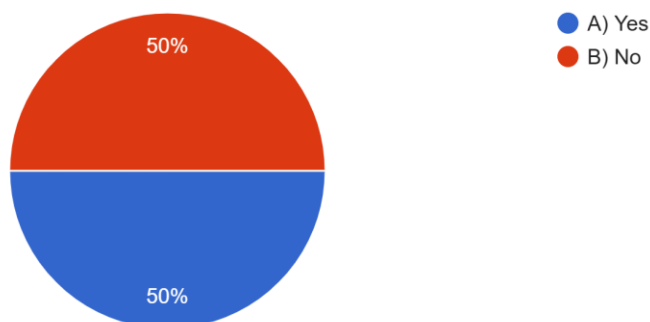

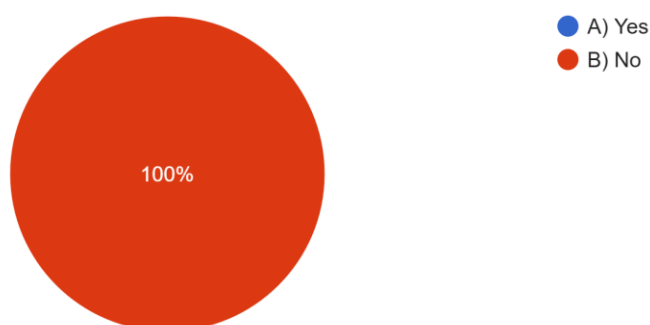

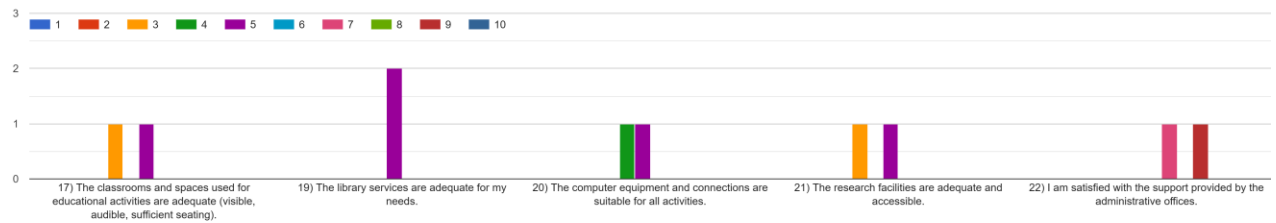


Sez. A - 16) During the course, have research activities been carried out promoting technology transfer in collaboration with companies?

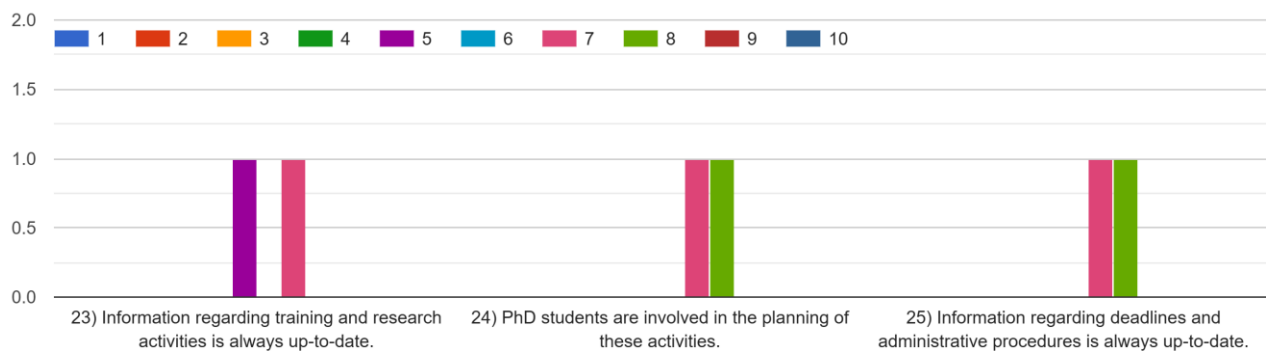
