CALL FOR 25 PLACES RESERVED FOR NON-EU CITIZENS FOR ENROLLMENT IN THE FIRST YEAR OF THE MASTER'S DEGREE COURSE IN SPORT MANAGEMENT – Curriculum Sport Events Management (class LM-47) Delivered in English UNIVERSITY OF CASSINO AND SOUTHERN LATIUM Academic Year 2023/2024

DECREES

Article 1

To announce an open competition, based on qualifications, for **25 places reserved for non-EU citizens**, for enrollment in the first year of the master's degree Course in SPORT MANAGEMENT - Curriculum Sport Events Management (class LM-47), delivered in English for the academic year 2023-2024

Article 2

To participate in the selection process, students are required to hold a three-year degree or equivalent in the areas of sport and exercise sciences, economics and law, as well as in the areas referred to the following ISCED Codes: 04 Business Studies and Management, 10 Law, 14 Social Sciences – obtained by the deadline of this call. Candidates who, on the date of expiry of the present call, are in the position to obtain the Degree no later than December 31st 2023, can also participate sub judice

Article 3

Candidates are required to have the following qualifications:

a) university qualification obtained at a higher education institution that allows the continuation of studies at the next level in the relevant academic institutions in the country where the final qualification is obtained; the final qualification must alternatively be accompanied by a certificate issued by ENIC-NARIC centres or from the Declaration of Value.

b) certificate issued by the competent University attesting the exams passed (transcript); the Diploma Supplement, where adopted, can attest to the program of studies;

c) translations into Italian, if the documents indicated in a) and b) are issued in languages other than Italian, French, English, Spanish or Russian;



d) attestations or certifications showing knowledge of the language in which the study program is delivered (English).

Article 4

The attestation or certification referred to in *art.* **3** paragraph **d**, relating to knowledge of the English language, must be at least of B1 level.

Articles 5

Without a suitable linguistic certification, the Commission reserves the right to assess the knowledge of the English language through an online interview. Candidates will be summoned via e-mail, and the date will be advertised on the web page https://www.unicas.it/studenti/international-students.aspx

Article 6

Applicants must follow the "Procedures for the entry, stay and enrolment of international students and the related recognition of qualifications, for higher education courses in Italy, valid for the 2023-2024 academic year" published annually by the MUR on the web page https://www.studiare-in-italia.it/studentistranieri/

Article 7

The application must be made exclusively online using the platform managed by CASI at the link <u>https://eventi.uniclam.it/SportMng/Login/Login.php</u>, uploading the identity documents and academic documents required by art. 3, by **July 5th2023** with the simultaneous payment of \notin 30.00 as a fee for admission to the selection. The competition fee is non-refundable.

Article 8

The ranking list of those admitted to the master program LM-47 will be published by **July 17th 2023** on the website: https://www.unicas.it/studenti/international-students.aspx

Article 9

Candidates usefully placed in the ranking, in compliance with Ministerial Procedures, are required to register on the Universitaly portal https://www.universitaly.it/index.php/registration/firststep and to upload all the related academic documents no later than **September 14th 2023**, to apply for an entry visa to Italy for study purposes.

Article 10

After admission to Universitaly and obtaining a student visa, applicants are required to follow the University's instructions published on the website https://www.unicas.it/studenti/international-students.aspx

Article 11

The administrative formalities established for participation in the selection, completion of enrolment or in any case enrolment in the first year of the Master's Degree Course LM-47, are those set out in this notice, and do not necessarily coincide with the criteria established for the general of the students of the University of Cassino and Southern Latium.
