

### TUITION FEES academic year 2023-2024

The annual amount of tuition fees is 1556 euros (a fixed amount, plus the Regional fees 140 euros, plus the stamp duty 16 euros).

It reduced up to 756 euros based on the Country of origin.

UNICAS tuition fees are totally waived (except for the stamp duty of 16 euros) for DiSCoLAZIO scholarship winners.

If you don't have the LAZIODISCO scholarship, you have to pay the fees. Fees are divided into three annual installments with due dates:

October 16 - first installment

March 31 - second installment

May 31 - third installment

You can apply to the Office for an installment in 12 installments at zero interest at the Banca Popolare del Cassinate. You will enter into a contract with the Bank and you are responsible for paying every 20th of the month on the payment forms that the Bank will give you. Each month the Office checks if you are paying and you will be notified with the possibility of a career freeze if you do not pay monthly.

To get installment payments, you must come in person to the Office, which must authorize you specifically.

Fees must be paid on time, otherwise will be applied penalties which the Office CANNOT ELIMINATE.

The late payment cannot be more than the contribution due.

In case of late notice of revocation of scholarships by the DiSCo Lazio Institution, a minimum late payment of € 25.00 will be applied to students on any all-inclusive contribution due.
