Professional profile. Francesco Ferrante is a Full Professor of Economics at the Università di Cassino e del Lazio Meridionale. He earned a PhD in Economics and an MSc in Economic and Social Policy Analysis from the University of York (UK).

His academic and research activities focus on **entrepreneurship economics, economics of higher education, innovation and sustainability, and labor market institutions and dynamics**. A key unifying theme in his research is the **central role of human capital**, in its various forms, in shaping economic and technological progress.

His research explores the role of human capital in economic development, specifically in areas such as **entrepreneurial talent, employability, and innovation dynamics**. He has authored numerous peer-reviewed publications in international journals addressing topics related to the relationship between education and labor market outcomes, the effectiveness of policy interventions in fostering innovation, and the socio-economic impacts of technological advancements. In addition to his academic research, he has been involved in multiple **technology transfer initiatives**, supporting the development of university spin-offs and collaborations between academia and industry. He has held leadership roles in initiatives aimed at enhancing knowledge transfer processes, including serving as the Deputy Rector for Technology Transfer and Chair of the Spin-off Commission at the Università di Cassino e del Lazio Meridionale. These roles involved overseeing the commercialization of research outputs, supporting the creation of innovative start-ups, and facilitating partnerships with industrial stakeholders.

As the founder of **ImprendiLab**, a university-based laboratory for entrepreneurship promotion and knowledge transfer, he has played a key role in fostering entrepreneurial talent. Over the past decade, **ImprendiLab has supported more than 70 entrepreneurial projects**, providing mentorship, training, and access to innovation networks. Additionally, through the **FSTE (Four Steps to Entrepreneurship) program, more than 500 students, graduates, and researchers have participated in structured entrepreneurial training**. This initiative has contributed significantly to the dissemination of entrepreneurial skills, enhancing employability and fostering the creation of innovative startups.

Professor Ferrante is an active member of several research and policy advisory boards, including **AlmaLaurea, Premio Nazionale Innovazione (PNICube) and Netval**. His involvement in these organizations focuses on areas such as higher education performance analysis, technology transfer strategies, and labor market policy evaluation. He also holds the **Registered**

Technology Transfer Professional (RTTP) certification, which signifies his expertise in managing and implementing technology transfer processes in academic settings.

His professional experience includes teaching at both undergraduate and postgraduate levels, covering topics such as **macroeconomics, labor economics, economics of human capital, entrepreneurship, political economy of development and innovation economics**.

As part of the **Third Mission** of the university, Francesco Ferrante's activities extend beyond traditional teaching and research, focusing on the societal impact of academic knowledge. His commitment to technology transfer, entrepreneurship promotion, and industry collaboration aligns with the broader goal of fostering innovation and economic development.
